The Ward's Guardians have been advised that the Ward executed a Ratification of a Five year lease to another Lessee on October 16, 1987, relating to the property described in the above referenced Lease, and have determined that the Ward should refund all monies paid by Lessee to the Estate, pursuant to the July 12, 1989 Lease, and to surrender and cancel the Lease.
