Tonkin Springs Venture Limited Partnership, a Nevada limited partnership, having a mailing address of P.O. Box 557, Eureka, NV 89316 has located the DEN 8 mill site, more particularly described below. The time and date of location is 3:44 p.m. on the 19th day of October, 1991.

The number of acres claimed is five.

This mill site is located in the Northwest Quarter of Section 2, Township 23-1/2 North, Range 49 East, Mount Diablo Base and Meridian, Eureka County, Nevada, and is described by metes and bounds as follows:

Beginning at Corner No. 1, which Corner No. 1 bears South 89 degrees, 56' 16" East, a distance of 770.156 feet from the Northwest corner of Section 2, Township 23-1/2 North, Range 49 East, which corner is marked by a G.L.O. Brass Cap Monument;
