The number of acres claimed is five.

This mill site is located in the Northwest Quarter of Section 2, Township 23-1/2 North, Range 49 East, Mount Diablo Base and Meridian, Eureka County, Nevada, and is described by metes and bounds as follows:

Beginning at Corner No. 1, which Corner No. 1 bears South 89 degrees, 56' 16" East, a distance of 2156.437 feet from the Northwest corner of Section 2, Township 23-1/2 North, Range 49 East, which corner is marked by a G.L.O. Brass Cap Monument;
