This mill site claim is five acres in size and is more particularly described as being the North Half of the Northwest Quarter of the Southwest Quarter of the Northeast Quarter of Section 2, Township 23-1/2 North, Range 49 East, Mount Diablo Base and Meridian, Eureka County, Nevada.
