CORRECTION QUITCLAIM DEED AND ASSIGNMENT

By a Quitclaim Deed and Assignment, effective as of 12:03 a.m., August 7, 1990, the Bullion-Monarch Venture, aka the Bullion-Monarch Joint Venture, a joint venture among Westmont Gold Inc., a Delaware corporation, The Petrol Oil & Gas Corporation, a Delaware corporation, United El Dorado Corporation, a Nevada corporation, Camsell River Investments Ltd., a Canadian corporation, Lambert Holdings Ltd. (successor by corporate amalgamation to Eltel Holdings Ltd.), a Canadian corporation, and Lost Dutchman Construction, Inc., a Nevada corporation, conveyed to High Desert Mineral Resources, Inc., a Nevada corporation, (a name under which High Desert Mineral Resources of Nevada, Inc. was doing business) certain interests in patented and unpatented mining claims, leasehold interests and other rights. A copy of the above-described Quitclaim Deed and Assignment is recorded as Document No. 133057 in Book 212 at Pages 327-334 of the records of Eureka County, Nevada. The Bullion-Monarch Venture was dissolved effective November 30, 1990, pursuant to an Agreement for Termination of Joint Venture, a copy of which is recorded in Book 219 at Pages 511-518 of the records of Eureka County, Nevada.

High Desert Mineral Resources of Nevada, Inc., a Nevada corporation, whose address is P. O. Box 2008, Elko, Nevada ("Grantee") and The Petrol Oil & Gas Corporation, a Delaware corporation, ("Grantor") desire to correct the corporate name of the grantee and the names and descriptions of certain claims in the above-described Quitclaim Deed and Assignment. This Correction Quitclaim Deed and Assignment is intended solely to correct the matters specified above and is not intended as a waiver or enhancement of the substantive rights of the parties hereto. This Correction Quitclaim Deed and Assignment is effective as of 12:03 a.m., August 7, 1990.

Recitals

Pursuant to an Option Agreement, dated effective April 26, 1990, between the Bullion-Monarch Venture and Grantee, ("Option Agreement") Grantee exercised its right to acquire all of the Bullion-Monarch Venture's right, title, and interest in and to the unpatented lode mining claims and millsite claims ("Unpatented Claims") and the patented lode mining claims ("Patented Claims") identified in Exhibit A hereto, and in that

certain Lease and Option, dated August 13, 1969, by and between R.D. Rubricht and Mary Jo Rubricht, his wife, and Fred Kurtz, as lessors, and the Bullion Monarch Company, as lessee, a copy of which is recorded in Book 71, at Page 433 of the records of Eureka County, Nevada ("the Lease"), except those interests specifically excepted and reserved herein. The Bullion-Monarch Venture has previously executed and delivered to Grantee an Assignment of all of its right, title and interest in and to the Lease. The Bullion-Monarch Venture has previously executed and delivered to Grantee a Deed of the Unpatented Claims and certain interests in the Patented Claims. Grantee has previously executed and delivered to the Bullion-Monarch Venture a Deed of Non-Participating Net Smelter Return Royalty with respect to the Patented Claims and the Unpatented Claims and the claims subject to the Lease (the "Leased Claims"). Grantor and Grantee intend that the representations, warranties and indemnities contained in the Option Agreement, the Deed, and the Assignment of Lease shall survive and not be merged in this Correction Quitclaim Deed and Assignment.

Agreement and Conveyance

For and in consideration of ten dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantor does hereby remise, release, quitclaim, convey and assign unto Grantee forever all of Grantor's right, title, and interest in and to the Lease, the Patented Claims, the Unpatented Claims, and the Leased Claims, and the lands subject thereto, and all rights and interests appurtenant to or associated therewith, including geothermal rights, water rights, remainders, reversions, options and contractual rights.

Excepting and reserving to Grantor, the following:

- 4. The facilities, machinery, equipment (including but not limited to pump, casing and pipeline associated with the water well included within Permit No. 30615) and mobile home and other personal property located in the West 1/2 of Section 10, Township 35 North, Range 50 East of the Mt. Diablo Base and Meridian, known as the Universal Gold Mill;
- 5. The Deed of Non-Participating Net Smelter Return Royalty dated as of 12:02 a.m., August 7, 1990, between the Bullion-Monarch Venture and Grantee.
- 6. The right of Petrol Oil and Gas Corporation to gain reasonable access on advance written notice to Grantee to the Universal Gold Mill for six (6) months from and after the date of this deed for the sole purpose of removing the same at its sole cost and expense, in full compliance with all laws, rules and regulations of state, federal and local governments, and subject

to the obligations of the Petrol Oil and Gas Corporation and the other parties comprising the Grantor with respect to reclamation of the area disturbed by the Universal Gold Mill as provided under the Sale Agreement between the parties comprising the Grantor, dated January 15, 1990, and, provided further, that no action taken by any of the parties comprising the Bullion-Monarch Venture shall adversely affect or impair the water rights included within Permit No. 30615.

The Unpatented Claims and Patented Claims conveyed herein are expressly transferred and conveyed free and clear of the Net Profits Royalty Interest and any and all other right, title, claim or interest created by that certain Agreement, Assignment and Conveyance of Net Profits Royalty Interest dated October 31, 1986, between NICOR Mineral Ventures Inc. and NICOR Minerals Inc. and recorded at Book 152, Page 047 of the Official Records of Eureka County, Nevada and amended on November 9, 1988, by Amendment No. 1 as recorded at Book 193, Page 261 of the Official Records of Eureka County, Nevada, (The "Agreement"). This transfer and conveyance is made pursuant to Section 3(c) of the Agreement and shall constitute a "Free-and-Clear Transfer or Conveyance" under the terms thereof.

To have and to hold the above-described property together with the appurtenances, unto Grantee and its successors and assigns, forever.
