MOUNT DIABLO MERIDIAN, NEVADA. SAID CLAIM LIES WITHIN THE NW 1/4 Sec. 5,  
Section 6, T23N, R50E MDM. FROM THIS DISCOVERY MONUMENT, THE  
UNDERSIGNED CLAIMS 10 FEET IN AN/AN EAST DIRECTION, AND, 1490  
FEET IN A/AN WEST DIRECTION, AND, 300 FEET ON EACH SIDE OF THE MIDDLE
