## CLARIFICATION, MODIFICATION AND AMENDMENT OF MINING DEED

THIS CLARIFICATION INDENTURE is made effective the 2nd day of April, 1990, by and between INTERNATIONAL METALS AND ENERGY CORP., a Utah corporation, WILLIAM S. GRAY & CO., a Delaware corporation, W. ROY HOGAN, HUGH E. HANAGAN, SUSAN McRAE (successor-in-interest to EDWARD W. McRAE, deceased), JAMES C. RICHARD, hereinafter collectively referred to as Grantor, and EURO-NEVADA MINING CORPORATION, INC., a Nevada corporation, and FRANCO-NEVADA MINING CORPORATION, INC., a Nevada corporation, hereinafter collectively referred to as Grantee. The Grantor, for and in consideration of the sum of TEN DOLLARS (\$10.00) lawful money of the United States of America, together with other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and Grantee hereby clarify, modify and amend that certain Mining Deed ("Mining Deed") dated April 2, 1990, between Grantor and Euro-Nevada Mining Corporation, Inc., recorded in the official records of Eureka County, Nevada on April 5, 1990 as Instrument No. 132107, at Book 209, Pages 405-413.

Section 2, "EXCEPTION AND RESERVATION" of the Mining Deed shall be, and hereby is, clarified, modified and amended to read as follows:

2. Sale or Other Disposition Royalty. In the event Grantee sells, conveys, joint ventures, or otherwise disposes of the Property, the Grantor shall receive from the Grantee, *in lieu and in place of the 2% NSR*, twenty percent (20%) of all consideration ("Consideration") received by the Grantee at the time of sale, conveyance, joint venture, or other disposition and thereafter. The twenty percent (20%) of the Consideration to be received from the Grantee by the Grantor shall hereinafter be referred to as the "Sale Interest". The Consideration, including without limitation royalty payments that may be received by the Grantee in the future, from the sale, conveyance, joint venture or other disposition of the Property shall be received by Grantee as its sole property; provided, however, Grantee shall be solely responsible and obligated to deliver the Sale Interest to the Grantor in accordance with the terms and provisions of this Indenture. The Grantee shall deliver the Sale Interest to the Grantor within thirty (30) days of the receipt of the Consideration by Grantee, together with such accounting data received by Grantee with the Consideration which is necessary to account for the calculation of the Sale Interest. In the event of a default by Grantee under this Section 2 or a dispute between Grantor and Grantee regarding the Sale Interest, Grantor's sole and exclusive remedy shall be against the Grantee and not against other parties which may have delivered valuable purchase or other consideration to the Grantee for rights or interests in and to the Property.
