Corner No. 4 is a 3 inch diameter x 5 foot long, solid, capped PVC pipe.

Corner No. 5 is a 3 inch diameter x 5 foot long, solid, capped PVC pipe.

Corner No. 6 is a 3 inch diameter x 5 foot long, solid, capped PVC pipe.

The monumentation and marking of the corners was completed by the 12th day of November, 1991.
