Corner No. 4 is a 3 inch diameter x 5 foot long, solid, capped PVC pipe.

Corner No. 5 is a 3 inch diameter x 5 foot long, solid, capped PVC pipe.

Corner No. 6 is a 3 inch diameter x 5 foot long, solid, capped PVC pipe.

The monumentation and marking of the corners was completed by the 12th day of November, 1991.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Eureka County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
