SPECIAL WARRANTY DEED

It is the intent of the Grantor and Grantee that this Special Warranty Deed be given effect prior to the Special Warranty Deed dated as of December 23, 1991 from Grantee to High Desert Mineral Resources of Nevada, Inc.
