CERTIFICATE OF LOCATION  
LODE CLAIM

TO ALL WHOM IT MAY CONCERN:

The undersigned hereby certifies that he has caused to be located the LONE # 9  
lode mining claim on the 5th day of November, 1991.

Said Claim is located in the protracted  
NE/4 of Sec. 18, Twp. 20 North, Range 51 East ;  
SE/4 of Sec. 18, Twp. 20 North, Range 51 East ;  
NW/4 of Sec. 18, Twp. 20 North, Range 51 East ;  
SW/4 of Sec. 18, Twp. 20 North, Range 51 East ;  
Mount Diablo Base and Meridian, Eureka County, Nevada.

To tie this claim to the Public Survey, begin at the SW corner of Section 19,  
Township 20 North, Range 52 East, Mount Diablo Base and Meridian, thence  
13,400 feet North and 30,400 feet West to the Northeast corner of this  
claim.

The general course of the lode or vein is East and West.

We (or I) claim 1500 linear feet along the course of the ledge, lode or vein,  
extending 10 feet from the location monument in a Easterly direction and 1490  
feet in a Westerly direction, together with 300 feet on each side of the center of  
the ledge for the entire length of the claim.

The exterior boundaries of this claim are clearly marked by solid PVC pipe, capped  
and firmly set in the ground and bearing applicable monument designation. The description of  
such claim is: Beginning at the Northeast Corner :

thence, South 600 feet to the Southeast Corner, a 3" in diameter by 5' in length PVC Pipe,  
thence, West 750 feet to the South Side Center, a 3" in diameter by 5' in length PVC Pipe,  
thence, West 750 feet to the Southwest Corner, a 3" in diameter by 5' in length PVC Pipe,  
thence, North 600 feet to the Northwest Corner, a 3" in diameter by 5' in length PVC Pipe,  
thence, East 750 feet to the North Side Center, a 3" in diameter by 5' in length PVC Pipe,  
thence, East 750 feet to the Northeast Corner, a 3" in diameter by 5' in length PVC Pipe,  
the point and place of beginning.

The Monumentation and marking of the exterior boundaries of this claim was completed by  
the 18th day of November, 1991.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies  
of this claim map have been filed with the Eureka County Recorder, and the lode claim  
filing fee has been paid to the County Recorder.
