ASSIGNMENT OF OVERRIDING ROYALTY

NOW, THEREFORE, for and in consideration of the sum of One Dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Dennis Brouse does hereby bargain, sell, transfer, assign, and convey to Foreland Corporation, its heirs and assigns, an overriding royalty of .25% of 8/8ths of the market value at the wells as produced of all oil, gas and other hydrocarbons that may be produced, saved and sold from each of the above described leased acreage under said leases, or any renewals or extensions thereof, free of all cost and expenses, except taxes and assessments levied upon or against or measured by the production of oil and gas from said land.

SAID OVERRIDING ROYALTY by this assignment shall offset those assignments dated October 18, 1990 and recorded in Elko and Eureka Counties at Book 737, Pages 992, 993, and 994 of the official records Elko County, Nevada and at Book 217, Pages 069, 070, and 071 of the official records of Eureka County Nevada. Furthermore, it is the intent of this assignment to merge said overriding royalty into record title as a benefit inuring unto Foreland Corporation, its heirs, administrators, executors and assignees, forever. This assignment is made without warranty of title, express or implied.
