CERTIFICATE OF LOCATION  
LODE MINING CLAIM

The undersigned citizen of the United States, as agent for Herb Duerr, 127 Cheney St., Reno, Nevada 89501, hereby declares as follows, to wit:

That on the 9th day of Nov., 1991, the above lode mining claim was duly located in the Cortez Mining District, Eureka County, Nevada.

The locator hereby claims 1475 feet in a North direction and 25 feet in a South direction from the location monument and 300 feet on each side of said lode or vein. The general course of this claim is North-South.

That the following reference is hereby made to natural objects and permanent monuments so as to identify said claim, to wit:

The discovery monument is located approximately 7000 feet in a N60°30'E direction from Bench Mark (BM) 4822.3 located in sec 18 T.27N R.48E MDM Lander Co.

Within 60 days after posting notice on the ground, the locator defined the boundaries of the claim as required by law and established monuments consisting of 3.5 x 3.5 inch wooden posts, native timber, 3 inch diameter PVC pipe or rock monuments. Each monument is marked with the name of the claim and a diagram or statement indicating its location. Location work consisted of making the maps in accordance with NRS 517.040, which are recorded herewith.
