CERTIFICATE OF LOCATION

That the following reference is hereby made to natural objects and permanent monuments so as to identify said claim, to wit:

The discovery monument is located approximately 8440 feet in a N40.30'E direction from Bench Mark (BM) 4822.3 located in sec 18 T27N R48E MDM Lander Co.

Within 60 days after posting notice on the ground, the locator defined the boundaries of the claim as required by law and established monuments consisting of 3.5 x 3.5 inch wooden posts, native timber, 3 inch diameter PVC pipe or rock monuments.
