CERTIFICATE OF LOCATION

Within 60 days after posting notice on the ground, the locator defined the boundaries of the claim as required by law and established monuments consisting of 3.5 x 3.5 inch wooden posts, native timber, 3 inch diameter PVC pipe or rock monuments.
