The Undersigned hereby certifies that he, on behalf of Newmont Exploration Limited, has caused to be located the ATRUST #8 Lode Mining Claim in the SE $\frac{1}{4}$  of Section 20, and NE $\frac{1}{4}$  of Section 29, Township 31 North, Range 51 East, M.D.M., situated in Safford Mining District, Eureka County, Nevada, on the 27th day of November, 1991.
