ROYALTY DEED and AGREEMENT

This Royalty Deed and Agreement is made effective January 1, 1992 between Tonkin Springs Venture Limited Partnership, a Nevada limited partnership, having a mailing address of P.O. Box 557, Eureka, NV 89316 ("Venture") and Precambrian Exploration, Inc., a Nevada corporation whose principal place of business is P.O. Box 352, 450 Post Road East, Westport, Connecticut 06881 ("PEX").

1. On November 1, 1987 Silver State Mining Corporation ("Silver State") and PEX entered into that certain Deed and Agreement covering the Rob unpatented claim group ("Rob Claims"), which Deed and Agreement is recorded in Book 170 at Page 436 of the official records of Eureka County, Nevada ("Silver State Agreement").

2. On September 7, 1989 Silver State quitclaimed all of its interest in the Rob Claims to its affiliant, Tonkin Springs Gold Mining Company ("TSGMC"), in that certain Quitclaim Deed recorded in Book 202 at Page 441 of the official records of Eureka County, Nevada.

3. On February 13, 1991 TSGMC conveyed all of its interest in the Rob Claims to the Venture in that certain Deed and Assignment recorded in Book 220 at Page 250 of the official records of Eureka County, Nevada.

4. The Venture has relocated certain of the Rob Claims, all of which relocated claims are known as the "ROBR Claims".

5. The Venture hereby grants to PEX a perpetual royalty of two percent Net Smelter Returns on the same terms and conditions set forth in the Silver State Agreement on production from those certain ROBR Claims included on Exhibit A attached hereto.

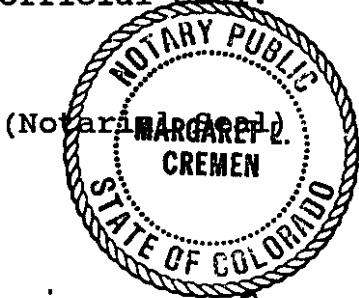
