CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that ATLAS PRECIOUS METALS INC., by its Agent, the undersigned, does hereby locate the ES 9 Lode Mining Claim on this 10th day of January, 1992, situated in the Unknown Mining District, Eureka County, Nevada.

Said Claim is located in the NW(SW) (Quarter) Section(s) 13(13), Township 22 North, Range 50 East, Mt. Diablo P.M., and is more particularly described as follows, to wit:

Beginning at the northeast corner post No. 1,

- Thence, 600 feet in a south direction to Post No. 2, marked - ES 9 -2
- Thence, 750 feet in a west direction to Post No. 3, marked - ES 9 -3
- Thence, 750 feet in a west direction to Post No. 4, marked - ES 9 -4
- Thence, 600 feet in a north direction to Post No. 5, marked - ES 9 -5
