THE UNDERSIGNED, hereby certifies that ATLAS PRECIOUS METALS INC., by its Agent, the undersigned, does hereby locate the ES 10 Lode Mining Claim on this 10th day of January, 1992, situated in the Unknown Mining District, Eureka County, Nevada.
