CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that ATLAS PRECIOUS METALS INC., by its Agent, the undersigned, does hereby locate the ES 18 Lode Mining Claim on this 7th day of February, 1992, situated in the Unknown Mining District, Eureka County, Nevada.

Said Claim is located in the SE(SW) (Quarter) Section(s) 13(13), Township 22 North, Range 50 East, Mt. Diablo P.M., and is more particularly described as follows, to wit:
