CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that ATLAS PRECIOUS METALS INC., by its Agent, the undersigned, does hereby locate the ES 24 Lode Mining Claim on this 7th day of February, 1992, situated in the Unknown Mining District, Eureka County, Nevada.
