

CERTIFICATE OF LOCATION

The Claim is approximately 1500 feet long and 600 feet wide, such that 20 feet is claimed in a SOUTHERLY direction and 1480 feet in a NORTHERLY direction from the point of discovery (monument of location), at which the Notice of Location was posted, together with 300 feet on each side of the monument of location and center line of the Claim. The general course of the lode or vein is from the NORTHERLY to the SOUTHERLY direction.

As erected on the ground, each side center or corner monument is marked as described above by FELT TIP MARKINGS ON POST (e.g. metal tags, paint on posts).

The work of location consisted of making a claim map as provided in N.R.S. 517.040.
