CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that NEWMONT EXPLORATION LIMITED, by its Agent, the undersigned, does hereby locate the MAG 40 Lode Mining Claim on this 2nd day of January, 1992, situated in the Unknown Mining District, Elko & Eureka, Counties, Nevada.

Said Claim is located in the NW(SW) (Quarter) Section(s) 32(29), Township 34 North, Range 52 East, Mt. Diablo Mer. and is more particularly described as follows, to wit:

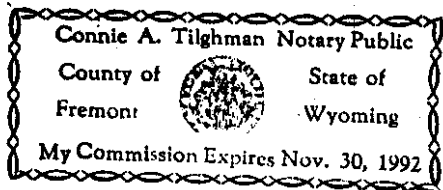
