CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that NEWMONT EXPLORATION LIMITED, by its Agent, the undersigned, does hereby locate the MAG 169 Lode Mining Claim on this 7th day of January, 1992, situated in the Unknown Mining District, Elko & Eureka Counties, Nevada.

Said Claim is located in the SW(SE) (Quarter) Section(s) 20(19), Township 33 North, Range 52 East, Mt. Diablo Mer., and is more particularly described as follows, to wit:

- Thence, 600 feet in a west direction to Post No. 4, marked - MAG 169 -4

The number of linear feet claimed in length along the course of the vein from the point of discovery is 10 feet in an east direction and 1190 feet in a west direction, together with 300 feet on each side of the center of the vein or lode for the entire length of the claim.

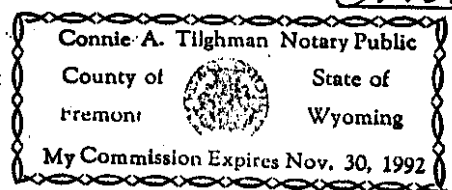
