CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that NEWMONT EXPLORATION LIMITED, by its Agent, the undersigned, does hereby locate the MAG 170 Lode Mining Claim on this 7th day of January, 1992, situated in the Unknown Mining District, Elko & Eureka Counties, Nevada.
