CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that NEWMONT EXPLORATION LIMITED, by its Agent, the undersigned, does hereby locate the MAG 171 Lode Mining Claim on this 7th day of January, 1992, situated in the Unknown Mining District, Elko & Eureka Counties, Nevada.

Said Claim is located in the SW(SE) (Quarter) Section(s) 20(19), Township 33 North, Range 52 East, Mt. Diablo Mer., and is more particularly described as follows, to wit:

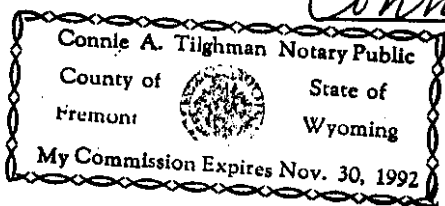
