CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that NEWMONT EXPLORATION LIMITED, by its Agent, the undersigned, does hereby locate the MAG 215 Lode Mining Claim on this 8th day of January, 1992, situated in the Unknown Mining District, Elko & Eureka, Counties, Nevada.

Said Claim is located in the NW (Quarter) Section(s) 32, Township 33 North, Range 52 East, Mt. Diablo Mer., and is more particularly described as follows, to wit:

the point of beginning and all monuments being wood posts.

The number of linear feet claimed in length along the course of the vein from the point of discovery is 1490 feet in a north direction and 10 feet in a south direction, together with 300 feet on each side of the center of the vein or lode for the entire length of the claim.

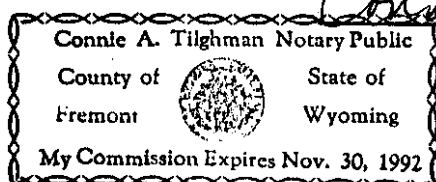
