THE UNDERSIGNED, hereby certifies that NEWMONT EXPLORATION LIMITED, by its Agent, the undersigned, does hereby locate the GIE 2 Lode Mining Claim on this 9th day of January, 1992, situated in the Unknown Mining District, Eureka County, Nevada.
