CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that NEWMONT EXPLORATION LIMITED, by its Agent, the undersigned, does hereby locate the GIE 3 Lode Mining Claim on this 9th day of January, 1992, situated in the Unknown Mining District, Eureka County, Nevada.

Said Claim is located in the NW(SW) (Quarter) Section(s) 6(6), Township 34 North, Range 52 East, Mt. Diablo Mer., and is more particularly described as follows, to wit:

The number of linear feet claimed in length along the course of the vein from the point of discovery is 10 feet in a north direction and 1490 feet in a south direction, together with 300 feet on each side of the center of the vein or lode for the entire length of the claim.

The general course of the vein or lode is north and south.
