CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that NEWMONT EXPLORATION LIMITED, by its Agent, the undersigned, does hereby locate the GIE 4 Lode Mining Claim on this 9th day of January, 1992, situated in the Unknown Mining District, Eureka County, Nevada.

Said Claim is located in the NW(SW) (Quarter) Section(s) 6(31), Township 34 N. (35 N.), Range 52 East, Mt. Diablo Mer., and is more particularly described as follows, to wit:
