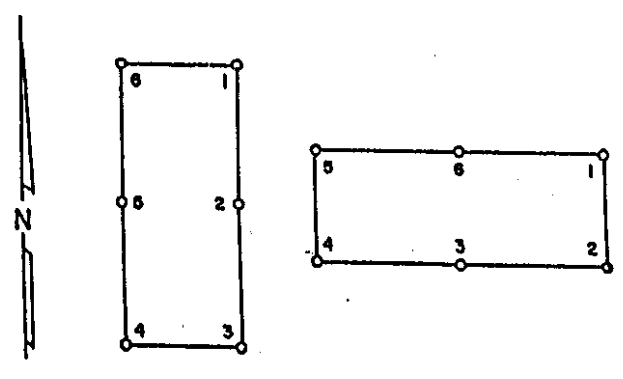

CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that NEWMONT EXPLORATION LIMITED, by its Agent, the undersigned, does hereby locate the GIE 8 Lode Mining Claim on this 9th day of January, 1992, situated in the Unknown Mining District, Eureka County, Nevada.

Said Claim is located in the NW(SW) (Quarter) Section(s) 6(31) Township 34 N. (35 N.), Range 52 East, Mt. Diablo Mer., and is more particularly described as follows, to wit:

Beginning at the northeast corner post No. 1,

Thence, <u>750</u> feet in a <u>south</u> direction to Post No. 2, marked - <u>GIE 8</u> - <u>2</u>
Thence, <u>750</u> feet in a <u>south</u> direction to Post No. 3, marked - <u>GIE 8</u> - <u>3</u>
Thence, <u>600</u> feet in a <u>west</u> direction to Post No. 4, marked - <u>GIE 8</u> - <u>4</u>
Thence, <u>750</u> feet in a <u>north</u> direction to Post No. 5, marked - <u>GIE 8</u> - <u>5</u>
Thence, <u>750</u> feet in a <u>north</u> direction to Post No. 6, marked - <u>GIE 8</u> - <u>6</u>
Thence, <u>600</u> feet in a <u>east</u> direction to Post No. 1, marked - <u>GIE 8</u> - <u>1</u>

the point of beginning and all monuments being wood posts

The number of linear feet claimed in length along the course of the vein from the point of discovery is 1490 feet in a north direction and 10 feet in a south direction, together with 300 feet on each side of the center of the vein or lode for the entire length of the claim.

The general course of the vein or lode is north and south.

To tie this Claim to the Public Survey, begin at the Northwest corner, Section 6, Township 34 N., Range 52 E., Mt. Diablo Mer., and bear north, 100 feet and east, 2300 feet to the northeast corner of this Claim.
