THE UNDERSIGNED, hereby certifies that NEWMONT EXPLORATION LIMITED, by its Agent, the undersigned, does hereby locate the GIE 16 Lode Mining Claim on this 9th day of January, 1992, situated in the Unknown Mining District, Eureka County, Nevada.
