CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that NEWMONT EXPLORATION LIMITED, by its Agent, the undersigned, does hereby locate the GIE 124 Lode Mining Claim on this 14th day of January, 1992, situated in the Unknown Mining District, Eureka County, Nevada.

Said Claim is located in the NE(SE) (Quarter) Section(s) 18(7) Township 34 North, Range 52 East, Mt. Diablo Mer., and is more particularly described as follows, to wit:
