The work of location consisted of making the maps as provided in NRS 517.040. Dated January 30 A.D., 1992, and filed in duplicate.

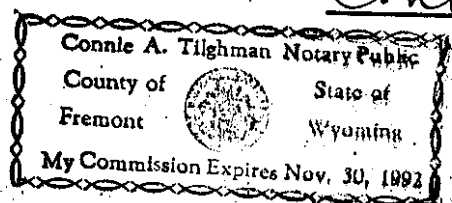
