CERTIFICATE OF LOCATION - NEVADA

The number of linear feet claimed in length along the course of the vein from the point of discovery is 1490 feet in a north direction and 10 feet in a south direction, together with 300 feet on each side of the center of the vein or lode for the entire length of the claim.

The work of location consisted of making the maps as provided in NRS 517.040. Dated February 14 A.D., 1992, and filed in duplicate.

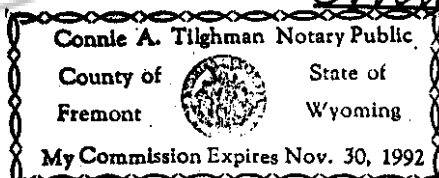
