## CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that NEWMONT EXPLORATION LIMITED, by its Agent, the undersigned, does hereby locate the COT 48 Lode Mining Claim on this 21<sup>st</sup> day of January, 1992, situated in the Unknown Mining District, Eureka County, Nevada.

the point of beginning and all monuments being wood posts

The number of linear feet claimed in length along the course of the vein from the point of discovery is 1490 feet in a north direction and 10 feet in a south direction, together with 300 feet on each side of the center of the vein or lode for the entire length of the claim.

The general course of the vein or lode is north and south.

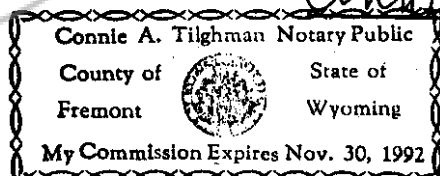
