CERTIFICATE OF LOCATION - NEVADA

The number of linear feet claimed in length along the course of the vein from the point of discovery is 10 feet in a north direction and 990 feet in a south direction, together with 300 feet on each side of the center of the vein or lode for the entire length of the claim.

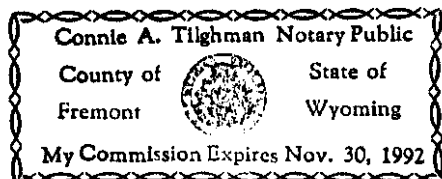
