CERTIFICATE OF LOCATION - NEVADA

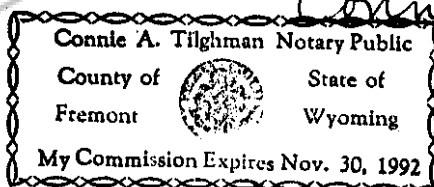
