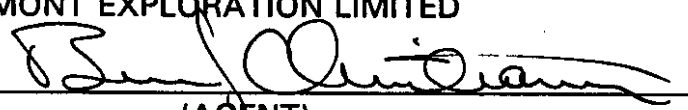
As erected on the ground, each side center or corner monument is marked as described above with marked aluminum tag.
