The Undersigned hereby certifies that he, on behalf of NEWMONT EXPLORATION LIMITED, has caused to be located the Bravo 8 Lode Mining Claim in the NE¼ of Section 10, Township 31 North, Range 49 East, M.D.M., in Eureka County, Nevada, on the 29th day of January, 1992.
