No. 6: NW Corner	NW Corner - Bravo 1	3" Dia.Non-Perf. Plastic Pipe w/Plastic Cap

As erected on the ground, each side center or corner monument is marked as described above with marked aluminum tag.


The work of Location consisted of making a claim map as provided in N.R.S. 517.040.
