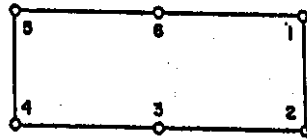

CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that NEWMONT EXPLORATION LIMITED, by its Agent, the undersigned, does hereby locate the WOL 219 Lode Mining Claim on this 14th day of February, 1992, situated in the Unknown Mining District, Eureka County, Nevada.

Said Claim is located in the NE(NW) (Quarter) Section(s) 30(30) Township 35 North, Range 52 East, Mt. Diablo Mer. and is more particularly described as follows, to wit:
