


CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that NEWMONT EXPLORATION LIMITED, by its Agent, the undersigned, does hereby locate the WOL 224 Lode Mining Claim on this 14th day of February, 1992, situated in the Unknown Mining District, Eureka County, Nevada.

Said Claim is located in the SE(SW) (Quarter) Section(s) 30(29) Township 35 North, Range 52 East, Mt. Diablo Mer., and is more particularly described as follows, to wit:

Beginning at the northeast corner post No. 1,

- Thence, 600 feet in a south direction to Post No. 2, marked - WOL 224 -2
- Thence, 750 feet in a west direction to Post No. 3, marked - WOL 224 -3
- Thence, 750 feet in a west direction to Post No. 4, marked - WOL 224 -4
