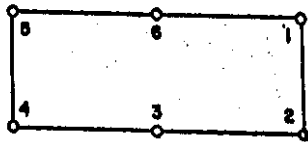
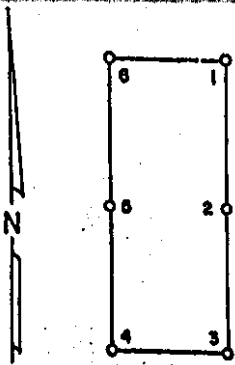

CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that NEWMONT EXPLORATION LIMITED, by its Agent, the undersigned, does hereby locate the WOL 232 Lode Mining Claim on this 14th day of February, 1992, situated in the Unknown Mining District, Eureka County, Nevada.

Said Claim is located in the NW(SW) (Quarter) Section(s) 31(30) Township 35 North, Range 52 East, Mt. Diablo Mer. and is more particularly described as follows, to wit:

Beginning at the northeast corner post No. 1,

- Thence, 750 feet in a south direction to Post No. 2, marked - WOL 232 -2
- Thence, 750 feet in a south direction to Post No. 3, marked - WOL 232 -3
- Thence, 600 feet in a west direction to Post No. 4, marked - WOL 232 -4
- Thence, 750 feet in a north direction to Post No. 5, marked - WOL 232 -5
