

CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that NEWMONT EXPLORATION LIMITED, by its Agent, the undersigned, does hereby locate the WOL 237 Lode Mining Claim on this 17th day of February, 1992, situated in the Unknown Mining District, Elko & Eureka Counties, Nevada.

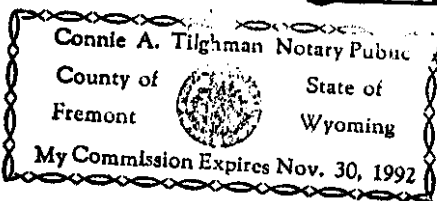
