

# CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that NEWMONT EXPLORATION LIMITED, by its Agent, the undersigned, does hereby locate the WOL 297 Lode Mining Claim on this 19th day of February, 1992, situated in the Unknown Mining District, Eureka County, Nevada.

the point of beginning and all monuments being wood posts

The number of linear feet claimed in length along the course of the vein from the point of discovery is 10 feet in a north direction and 1490 feet in a south direction, together with 200 feet on each side of the center of the vein or lode for the entire length of the claim.

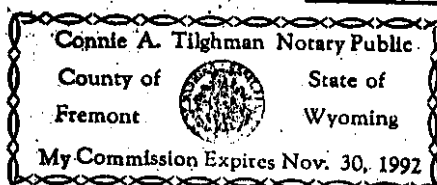
