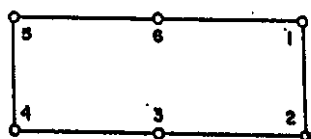

CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that NEWMONT EXPLORATION LIMITED, by its Agent, the undersigned, does hereby locate the WOL 298 Lode Mining Claim on this 19th day of February, 1992, situated in the Unknown Mining District, Eureka County, Nevada.

Said Claim is located in the NE(SE)(NW)(SW) (Quarter) Section(s) 19(18)(20)(17), Township 35 North, Range 52 East, Mt. Diablo Mer., and is more particularly described as follows, to wit:

Beginning at the northeast corner post No. 1,

Thence, <u>550</u> feet in a <u>south</u> direction to Post No. 2, marked - <u>WOL 298 -2</u>
Thence, <u>550</u> feet in a <u>south</u> direction to Post No. 3, marked - <u>WOL 298 -3</u>
Thence, <u>400</u> feet in a <u>west</u> direction to Post No. 4, marked - <u>WOL 298 -4</u>
Thence, <u>550</u> feet in a <u>north</u> direction to Post No. 5, marked - <u>WOL 298 -5</u>
Thence, <u>550</u> feet in a <u>north</u> direction to Post No. 6, marked - <u>WOL 298 -6</u>
Thence, <u>400</u> feet in a <u>east</u> direction to Post No. 1, marked - <u>WOL 298 -1</u>

the point of beginning and all monuments being wood posts

The number of linear feet claimed in length along the course of the vein from the point of discovery is 1090 feet in a north direction and 10 feet in a south direction, together with 200 feet on each side of the center of the vein or lode for the entire length of the claim.

The general course of the vein or lode is north and south.

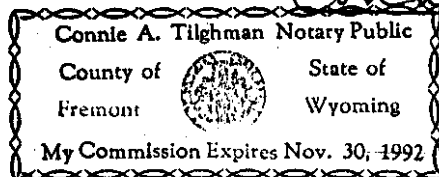
