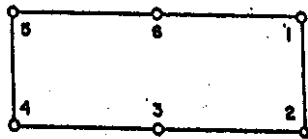
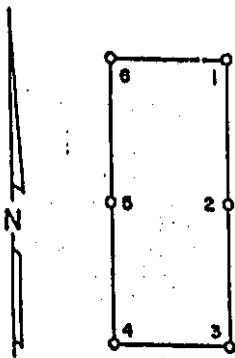

CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that NEWMONT EXPLORATION LIMITED, by its Agent, the undersigned, does hereby locate the WOL 299 Lode Mining Claim on this 19th day of February, 1992, situated in the Unknown Mining District, Elko & Eureka Counties, Nevada.

Said Claim is located in the NW (Quarter) Section(s) 20, Township 35 North, Range 52 East, Mt. Diablo Mer., and is more particularly described as follows, to wit:

Beginning at the northeast corner post No. 1,

- Thence, 750 feet in a south direction to Post No. 2, marked - WOL 299 -2
- Thence, 750 feet in a south direction to Post No. 3, marked - WOL 299 -3
- Thence, 600 feet in a west direction to Post No. 4, marked - WOL 299 -4
- Thence, 750 feet in a north direction to Post No. 5, marked - WOL 299 -5
