CERTIFICATE OF LOCATION

KNOW ALL MEN BY THESE PRESENTS, that PATHFINDER EXPLORATION CORPORATION, having an office and place of business at 255 Glendale Avenue, Suite 26, Sparks, Nevada 89431, has located the

lode mining claim this BW 10 16th day of April, 1992, under and by virtue of the mining laws and regulations of the United States and the State of Nevada.

The number of linear feet claimed in length along the course of the vein from the point of discovery is 1490 feet in a east direction and 10 feet in a west direction, together with 300 feet on each side of the center of the vein or lode for the entire length of the claim.

To locate this claim begin at BM 5636, dated 1937, inscribed GMM 7, and located within the SW1/4 Section 28, T.26 N., R.50 E., Mt. Diablo Meridian and bear south 12700 feet and east 4790 feet, to the northeast corner of this claim.

The general course of strike of the vein or lode as near as may be determined is east and west.
