CERTIFICATE OF LOCATION
KNOW ALL MEN BY THESE PRESENTS, that PATHFINDER EXPLORATION CORPORATION, having an office and place of business at 255 Glendale Avenue, Suite 26, Sparks, Nevada 89431, has located the
lode mining claim this 16th day of April, 1992, under and by virtue of the mining laws and regulations of the United States and the State of Nevada.
The number of linear feet claimed in length along the course of the vein from the point of discovery is 10 feet in a east direction and 1490 feet in a west direction, together with 300 feet on each side of the center of the vein or lode for the entire length of the claim.

Thence, 600 feet south to Post No. 2, the Southeast Corner BW 11 - 2 Thence, 750 feet west to Post No. 3, the South End Center BW 11 - 3 Thence, 600 feet west to Post No. 4, the Southwest Corner BW 11 - 4 Thence, 600 feet north to Post No. 5, the Northwest Corner BW 11 - 5 Thence, 750 feet east to Post No. 6, the Northwest Corner BW 11 - 5 Thence, 750 feet east to Post No. 6, the North End Center BW 11 - 6 Thence, 750 feet east to Post No. 1, the Northeast Corner BW 11 - 6
